GENERAL CONDITIONS OF PARTICIPATION

- The deadline of Application is mentioned at the Application form.
- The registered exhibitor is entitled to resign from the participation without paying any rental charges before the day of Fair's decision to accept the Application. After that term the renter that submitted is obligated to pay both the registration fee and entire rental sum.
- Once received the Application form, the Adriatic Fair (Jadranski sajam) distributes exhibition space and assigns the place to the exhibitor.
- After the acceptance of the Application, Fair sends the invoice calculated by the Application to the exhibitor. Term for payment of this invoice is immediately after receiving it.
- The payment is the condition of participation. All exhibitors are obligated to show the proof of payment to the Fair's authorized staff before the exhibition.
- The amount for additional services and for any difference between the requested and assigned space, should be paid by the additional invoice immediately after receiving it.
- Opening hours of the exhibition defines the Management of the Adriatic Fair.
- The exhibitor is not allowed to give to another exhibitor a part or entire stand without a permission of the Adriatic Fair.
- The insurance of the samples is at exhibitor's charge. The Fair is not responsible for the damages caused by disappearance, destruction or damage of that property during the exhibition at the Fair.
